On November 19, 2016 the Council of the Sahnoans unanimously passed constitutional amendments that create an entirely member elected Council. There will be no more "Historical Council" positions. In the past Council positions could only be appointed by existing Council members and served without term limitation. In the past Council members could only be removed by other Council members without input from the Sahnoan membership.

Your Council will be comprised of ten positions consisting of couples & individuals but will be subject to an open election process of alternating two year terms by the membership, allowing for full Sahnoan member participation in the governance of Star Ranch (C.O.G.) going forward.

There will soon be copies of the new constitution available through the office. In the meantime, as always, feel free to ask any Council member any questions you may have on the matter.

Chili Contest Rules January 28, 2017



No ingredient may be precooked or treated in any way prior to the commencement of the official cook off, with the following exceptions: canned tomatoes, tomato sauce, pepper sauce, beverages, broth, beans and grinding and mixing of spices; meat or meat substitute

may be precut or ground but not treated (seasoned in any way); all other ingredients must be chopped or prepared during the setup and cooking periods; you may precook your beans as long as you DO NOT add any spices or treatment while they are being cooked; each contestant will need to provide their own cookware and heating method for the preparation of the chili

Each contestant will be responsible for cleaning all of their own cookware and cooking space; the cooking period will be from 11:00 AM to 1:30 PM. All samples will be gathered in the same type container (provided by the Sahnoans), no accoutrements will be allowed; the chili MUST be cooked on-site the day of the cook off, out in the open; each contestant will be assigned a number by the scorekeeper and given a container in which their chili will be collected at the time of the official judging. Each contestant should verify that the number on the bottom of the container is the same number assigned to them.

History of the Christmas Stocking

In most families, it's a long standing tradition to hang Christmas stockings for every member of the family, even pets get their own stockings. These stockings are usually oversized socks that can be personalized with a name, filled with toys, candy & small gifts, often called stocking stuffers. Here is how this tradition got started:

Written records don't really indicate how the tradition of Christmas stockings got started, but there are several legends surrounding this tradition. The most trustworthy legend maintains that Saint Nicholas learned about a poor man who could not afford the pay a dowry for his three daughters, and he was worried about them. Saint Nicholas decided to help the man. He took three bags of gold with

him down the chimney of the man's home. Once inside, he found the girls' stockings hanging on the mantelpiece after washing to dry, Saint Nicholas added the gold bags to the stockings and then went about his Christmas Eve rounds. As the story spread, children began hanging their own stockings or putting out shoes, waiting for their own gifts.



Our Residents Voted For...America!

The recent General Election saw record turnouts in Bastrop County, as well as across the country. I was honored to be a Precinct Clerk for Pct. 4021 on November 8. Voting occurred at Faith Lutheran Church in McDade.

355 citizens voted here, which is not surprising. People were lined up before the doors opened at 7 AM, and traffic was steady all day.

I counted 12 Star Ranch residents(or 38%) who cast ballots. A smaller number had voted early. We have 39 adult residents, but 31 of those were on the property Election Day.

Irrespective of for whom our members cast their vote, we were exercising our right to vote, which is a BIG DEAL anywhere.

Voting is similar to jury duty: these are two forms of participation in which everyday citizens make a difference in the life of our fellow citizens. Sometimes voting for a "lesser of two evils" can be as undesirable as serving on a jury, but I have heard more than one judge address the panel about how important their service is to making our court system work. In the 55 years that I have voted in general elections, I have voted for five winners and five losers. The only bragging rights I have for that kind of record is found on the little stickers available at the ballot box saying "I voted." So thank you, fellow residents, for doing your part on November 8 as Americans.
