Cabins

As soon as the Club got a good start, members wanted shelters for sleeping and storing staple items to keep from transferring from home each visit. The first shelters were tents, then came along the cabins. The cabins were all one room, 12x14 feet, considered by the tax office as tin barns requiring little or no taxes. Approximately 66 cabins were built - only one has been torn down (at the time of the writing of the document). As Star Ranch and the Sahnoans grew, electricity and water were installed. In the 60's, larger cabins were requested with toilets, showers and septic tanks, and the cabins grew to 14x22 feet with a bathroom. The members who signed a "Cabin Deal" contract paid for all cabins in advance. Cabins depreciated at 10% per year.

RV and Factory Built Mobile Homes

As memberships increased, the need for cabins exceeded what could be built. RVs became popular and to live on Star Ranch, a mobile home was a must. Some cabin owners returned their cabins to COG and bought mobile homes. Members did not want to pull their units in and out each visit, so a program was implemented to allow RVs to be left on Star Ranch with water, power and some with septic tanks. Due to the cost of installing utilities and upkeep, a minimal fee was set to pay for availability when members arrived.

It does seem like history is repeating itself here at Star Ranch. As we grow, we have seen a variety of ways to make Star Ranch "home", from renovated original cabins, to modern class A, B, and C RVs, and installation of manufactured homes. People enjoy walking the grounds and seeing everyone's residences and sites. We are planning to give some much-needed attention to our ageing cabins to ensure they can be enjoyed for years to come.
