I had no idea "The Pines" were planted to block airplane landings. I have been very sad to have to deal with cutting down some of our beautiful mature pine trees that have died. We have lost many large trees due to severe weather events and insect infestations. I am planning to work on strategic replanting of seedlings to ensure that members 30 years from now can enjoy the beautiful canopy and the wind in the pines.

I wanted to give special recognition to our Fire Safety Committee. They have continuously worked to improve our fire readiness. We have earned our Firewise designation and I cannot wait to proudly display our recognition sign. Thank you everyone for your efforts to keep us fire safe and protect our unique environment. One of the things that the Firewise advisors commented on was that we have a burn pile that is managed by the club. Our staff is very conscientious about conditions and management of burns. We alert the McDade fire department very time we burn so they are aware in case things get out of control. I am glad we don't have to burn trash anymore! We have our hands full with brush especially after our recent "Tree-apocalypse". I think we have already burned three times since then and will need to do several more to get caught up before the burn bans start for the summer months.

We are gearing up for the start of the busy season. The race is happening on April Fools day. To me that is the beginning of the fun for the summer. I hope you will consider volunteering for that event. Watch the website for info on how to sign up as a volunteer or to run. I think we have hit our rhythm with getting ready for the event. We already have shirts in hand, medals ordered, a timing company reserved and 90 people registered. This is on track to be our biggest spring race ever. The word is out, it is fun!

Just a word about upcoming events. The Straw Poll and the Shareholders meetings are on the horizon. All members can vote in the Straw Poll regardless of if you hold a share or not. Please look at the bios of the folks who are running for the board and be sure to cast a vote in the straw poll. This helps inform those who hold shares as to who the membership as a whole, supports. If you are a gold member you are eligible to purchase a share for \$10 to vote in the shareholders meeting. I would encourage you to get out and talk to the candidates about their ideas and what skills they bring to the table. Board positions are voluntary but they do require thought, dedication and work. The Board works to keep the business side of the organization on track and coordinates with the Council on matters relating to activities and membership. I feel like the Board and Council have been working well together and we hope to keep that positive momentum going.

At long last I have finished getting the Star Ranch Community Policy and Rules compiled, formatted, reviewed, approved and published. I started this project over a year ago and it has been a long journey to get it done. The policies and rules were never well documented and had many versions located in obscure places. They are now on the Star Ranch website with an index and the update logs attached. These policies exist to preserve our safety, privacy, and livability at Star Ranch. Getting the policies in order has allowed me to finish up our new lease documents and reduce the number of pages in the lease by referencing the policies page instead of having to have all that information in the lease. I would encourage you to look them over. They are not written in stone. If there are errors or problems, we can revisit them and revise if needed. Thank you to all who have given comments and who have supported me in getting this project through to publication.

Well, that is about enough from me. I appreciate your support and input. Keep letting me know what is on your mind. We work best when we work together!


Here is the next installment of The Beginning and History of the Sahnos and Star Ranch by Merle and Ditto S.

Air Strip

Several members were pilots and owned their own airplanes. A landing strip 1800 foot long was cleared beside the LCRA transmission line. The strip was sand and the lower end was hard, but the topsoil was loose sand. If a pilot was unaware of the sand, which a few were, one flipped over on its top, one dragged his prop, and there were a few more accidents. One weekend, nine airplanes were parked at the gate. Because of unsafe conditions, an "X" was placed on the runway, indicating the strip was closed. Airplanes still landed and in order to stop them, pine trees were planted. Today we have "The Pines".

Garbage

Garbage is a necessary evil. Being in a rural area, no public garbage collection was available. Everyone in the country had a place to burn the burnable and bury metal. We dug large pits at different locations and later covered them up. A couple of times the fire got out of control and the McDade Fire Dept. came to our rescue. We did get rid of a lot of trash. Today we use a commercial sanitation company to pick up our growing garbage and take it to an authorized dump. Over one dump we had an archery range, which about 25 people used. That dump today still has a car and a Cushman scooter buried in it.


